HEMP BOMBS MINIMUM ADVERTISED PRICE POLICY

Global Widget dba Hemp Bombs (Hemp Bombs) manufactures lawful hemp products containing cannabidiol (CBD) in accordance with Federal law. As a distributor and/or reseller, you rely on the outstanding reputation of the Hemp Bombs brand in your decision to carry our products, and your customers look for the Hemp Bombs brand to know that they are purchasing premium products. Hemp Bombs' reputation can and will be damaged if its brand is perceived by consumers to be a discounted, or off-price, brand. For that reason, and in consideration of Hemp Bombs authorizing you to distribute and/or resell our products, we have determined that it is in the best interest of the Hemp Bombs brand to deal only with distributors and resellers who choose to sell our products at or above the Hemp Bombs' Minimum Advertised Price (MAP) as outlined in this policy, to which you agree by signing below.

Minimum Advertised Price Policy

Hemp Bombs believes that every one of our products should be offered to the consumer at no less than the MAP, as provided to you with this policy and as periodically updated, every day of the year. When MAP pricing guidelines change Hemp Bombs will distribute a new MAP file that includes the changes, which will become effective immediately and form an integral part of this this policy. Hemp Bombs reserves the right to exclude certain SKU's from this MAP policy.

Hemp Bombs appreciates the value brought by distributors and resellers with special pricing offers, such as sales and special promotions. We also appreciate that our commitment to bringing distributors, resellers, and consumers new products means that our distributors and resellers will, from time to time, be required to sell excess merchandise at a reduced price. It is desirable for both Hemp Bombs and our distributors and resellers that these occasional transactions be undertaken only in a systematic way that avoids damaging the favorable equities associated with the Hemp Bombs brand. Accordingly, occasional sales, special promotions, and closeouts will be permitted only when pre-approved by hemp Bombs in writing.

Practices Inconsistent with the MAP

Pricing practices that directly or indirectly reduce the price paid by the consumer for Hemp Bombs products will be considered to be a violation of the MAP.

Additionally, it is the express policy of Hemp Bombs not to sell its products through eBay or Amazon. In accordance with this policy, you agree not to sell our products through either of these channels.

Enforcement of the MAP

Hemp Bombs will monitor the practices of distributors and resellers. Distributors and Resellers are expected to provide reasonable cooperation with any Hemp Bombs investigations regarding possible MAP Policy violations. Hemp Bombs reserves the unilateral and unfettered right to terminate its business relationship with distributors or resellers who do not comply with the MAP policy.
